SALE CONDITIONS

1. Participation to sportive activities organised by Ascendance is subject to legal binding and agreement of the following sale conditions. Every participant must acknowledge with these terms by enclosing his initials and signature.
2. Ascendance cannot be held responsible of any incidents, accidents or injuries occurring during the exercise of our activities. Every participant must respect the advices and directives provided by Ascendance and by our local guides during the expeditions, particularly when related to security, flight paths and attitude to adopt in respect of Nepalese people.
3. Ascendance cannot be liable for compensation in case of rescheduling (change of dates, times, itineraries) of the expeditions, particularly when these modifications depend from meteorological events or perilous circumstances threatening the safety of the group.
4. Every participant must ensure that his general health, physical shape, skills to endure paragliding experiences and continuous outdoor life are adapted to the activities which he applied for.
5. Providing the sportive nature of the activities organised by Ascendance, it is absolutely necessary and compulsory to subscribe to a multi risks insurance covering injuries and related health care in the context of paragliding exercise which includes the cost of repatriation if you become too ill to continue.
6. The booking deposit is payable by cheque invoiced to « Ascendance ». The deposit must be enclosed with the booking form and sale conditions and sent to the following address : Ascendance, Auberge de Gourdon, Route de Caussols, 06620 Gourdon, France (if you cannot write a cheque in Euros, contact us to set up another way of payment). A non-refundable deposit of 25% of the total price of the package is payable 6 weeks before the departure of the session.
7. The payment of the S.I.V option, if not booked in advance must be made at Pokhara before the start of the Ascendance course, under reserve of space availability.
8. Cancellation from the participant :
Ascendance pays back the total price of the package less 25% if your written demand reaches us at least 6 weeks before the start of the session, after that period a 100% of the total price will be required. If after starting the session you decide to interrupt your trip, no refunds can be given.
We recommend yourself to subscribe to a travel insurance, please note that if the reason for cancellation falls within the terms of your insurance policy, then the insurance company will normally refund any such charges to you.
9. Cancellation from Ascendance :
Ascendance reserves the right to cancel the expedition in any circumstance without having to provide a justification, participants will then be integrally paid back without being able to claim for indemnities.
Plane tickets cannot be refunded by Ascendance. We advise you to buy refundable tickets and/or to subscribe to a cancelling insurance.
10. Participants of « XC Annapurnas sessions » must go to the meeting point defined by their own means : Kathmandu Airport.
11. Ascendance is not a travel agency. Therefore Ascendance is in no way related to transportation companies selected to reach Nepal. We cannot be held responsible for time and date rescheduling, flights cancellation, itineraries change, delays or baggage loss related to your travel to Nepal. Costs eventually occurring by such disturbances are completely at the participant charge.
12. Every participant must respect local laws and police formalities, customs and health regulations imposed by the authority of Nepal. In no case Ascendance will substitute to the individual responsibility of the participant who takes at its charge the completion of all formalities before departure (passport, visa, injections...) and for the duration of the travel as well as the accomplishment of all customs formalities regulating the exportation of objects such as antiquities, wild animals, fossils... Infringe of the laws or the lack or irregularity of travelling documents are the sole responsibility of the participant who will assume all costs involved.
